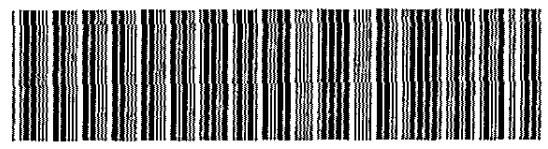



**ARTICLES OF INCORPORATION OF  
FRONTLINE EVANGELISTIC ASSOCIATION INC.**

**ARTICLE I – NAME & PRINCIPAL OFFICE**

The name of the Corporation shall be:

**FRONTLINE EVANGELISTIC ASSOCIATION INC.**

The principal place of business shall be:

**1001 Yamato Rd., Suite #306  
Boca Raton, Florida 33431-4403**

**ARTICLE II – DURATION**

Frontline Evangelistic Association shall exist perpetually commencing on the date these Articles are filed.

**ARTICLE III – PURPOSE**

Frontline Evangelistic Association exists to evangelize and propagate the Gospel of Jesus Christ, by any available means, including but not limited to licensing ministers of the Gospel, teaching, preaching the Gospel, the calling of a pastor, the election of the official board, the discipline of its members, and the conducting of its own services and church programs in the United States, its territories, and in foreign lands. Frontline Evangelistic Association shall have the right to govern itself and conducts its own affairs according to the standard of the Gospel of Jesus Christ.

**ARTICLE IV – MANNER OF ELECTION**

The Board of Directors of Frontline Evangelistic Association shall consist of Officers who shall serve by virtue of their office and such other ministers and laymen whom the Board of Directors may appoint. The Board of Directors shall establish a policy, serve as trustees of the

property (real and chattel), and supervise the entire association. It shall meet quarterly and shall elect its own officers annually.

- a.) Elections for the Board of Directors shall take place at the Annual Meeting held in the Fourth Quarter. Voting shall be by secret ballot and election by a majority vote of the Board of Directors of the corporation. The members of the Board of Directors who are not serving by virtue of their office shall be elected for a term of three years with one or more terms expiring each year.
- b.) The Board shall establish and maintain such departments and institutions as may be deemed necessary to accomplish its purposes.
- c.) Membership criterion shall be established by the Board of Directors and set forth in the By-Laws.
- d.) The duties, powers, and privileges of membership shall be established by the Board of Directors and set forth in the By-Laws.

#### **ARTICLE V – INITIAL BOARD OF DIRECTORS**

**ARTICLE VI – REGISTERED AGENT & ADDRESS**

**ARTICLE VIII – BY-LAWS**

The power to adopt, alter, amend, or repeal By-Laws shall be vested in the Board of Directors.

**ARTICLE IX – POWERS**

Frontline Evangelistic Association shall have all the corporate powers enumerated in the Florida General Corporations Act.

**ARTICLE X – INDEMNIFICATION**

Frontline Evangelistic Association shall indemnify any Officer or Director, or any former Officer or Director serving in its capacity, to the full extent permitted by law for any actions related to said business.

**ARTICLE XI – AMENDMENT**

Frontline Evangelistic Association reserves the right to amend or repeal any provisions contained in these Articles of Incorporation. Any Amendment hereto, and any right conferred upon the Directors, is subject to this reservation.


