The undersigned hereby submits these articles for the purpose of forming a corporation not for profit under Chapter 617, Florida Statutes, and certifies as follows:

ARTICLE I - NAME. The name of this corporation shall be GENESIS HOUSE, RSL, INC., which corporation shall herein be referred to as the "Company", and whose principal place of business shall be 2900 A-62nd Street North, Saint Petersburg, Florida 33702.

ARTICLE II - DURATION. This Company shall continue to exist in perpetuity until such time as the Board of Directors or other such designated party shall decide to terminate its existence according and in concert with the laws of the State of Florida..

ARTICLE III - PURPOSE. The purpose for which the corporation is organized is for the operation and management of a residential living facility for unwed, pregnant girls, located in Pinellas County, Florida known as GENESIS HOUSE RSL, INC., as well as any other purpose permitted under Florida Law.

ARTICLE IV - REGISTERED AGENT: The address of the corporation's initial registered office in the State of Florida is 2900 A-62nd Street North, Saint Petersburg, Florida 33702, and the name of its initial registered agent at such address is SONDRRA WOODARD.



ARTICLE VI - INCORPORATOR: The address of the Incorporator is 2900 A-62nd Street North, Saint Petersburg, Florida 33702, and the name of the Incorporator is SONDRA WOODARD.

ARTICLE VIII - DISSOLUTION: The Company shall be dissolved and its affairs wound up by a one hundred percent (100%) vote of the Board of Directors entitled to vote at a meeting called for such a purpose. In the event of dissolution, property of the Company shall be distributed after payment of, or adequate provision for, the debts and obligations of the corporation, to its Members as permitted by the court having jurisdiction thereof; provided, however, no such payment, benefit, or distribution shall be deemed to be a dividend or distribution of income. If the Company is dissolved, streets, roads, and surface water management systems easements on the Property, if any, shall be assigned or conveyed to an appropriate agency of local government and that if not accepted, the streets, roads, and surface water management system easements, if any, shall be dedicated to a similar non-profit corporation.


