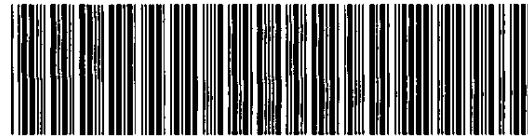

when both Developer and unit owners other than the Developer are entitled to
representation in which event the vacancy shall be filled by an election as provided in
Rule 61.23.0021, F.A.C.


