**AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF
A&B MANAGEMENT OF PENSACOLA, INC.**

In accordance with Sections 617.1002, 617.1006 and 617.1007 of the Florida Not For Profit Corporation Act (the "Act"), A&B Management of Pensacola, Inc., a Florida not for profit corporation (the "Corporation"), hereby amends and restates in its entirety its Articles of Incorporation as follows:

ARTICLE I.

The name of the Corporation is A&B Management of Pensacola, Inc.

ARTICLE II.

The Corporation is organized pursuant to the Act.

ARTICLE III.

The purposes for which this Corporation is organized are the establishment and support of any religious, charitable, scientific, literary or educational activities, within the meaning of Section 501(c)(3) of the Internal Revenue Code, either directly or indirectly through its cooperation with public or private agencies having like purposes or objects.

ARTICLE IV.

The principal place of business and mailing address of the Corporation is 33 Horseshoe Court, Pensacola, Florida 32513.

ARTICLE V.

The duration of the Corporation is perpetual.

ARTICLE VI.

The Corporation shall have no members.

ARTICLE VII.

The method of election of the directors of the Corporation shall be as set forth in the Bylaws of the Corporation.
