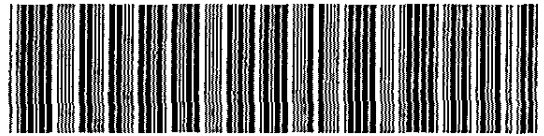

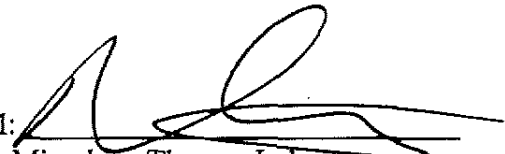

OF

a Florida Non-Profit corporation

The undersigned natural persons, a majority of whom are citizens of the United States of America and residents of the State of Florida, acting hereby as Incorporators for the purpose of forming a Not For Profit Corporation under Chapter 617, Corporations Not For Profit, Florida Statutes, do hereby adopt the following Articles of Incorporation:

Article I

Name

Article IV

Purpose

This nature and purposes of business to be transacted, promoted and carried on by the corporation are as follows:

a. To serve the Maya and Hispanic community of Palm Beach County by providing charitable activities, within the meaning of section 501^(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

b. This corporation shall have all of the corporate powers enumerated in Chapter 617, Corporations Not For Profit, Florida Statutes.

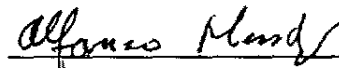
Article IX

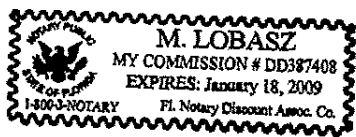

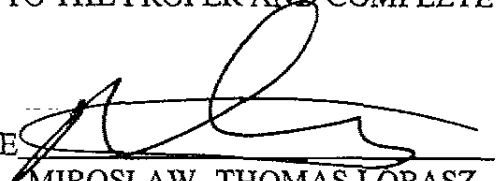
