

ARTICLES OF INCORPORATION

MASTER BROKERS FORUM OF BROWARD COUNTY, INC.

(In Compliance with Chapter 617, F.S. (Not for Profit)

ARTICLE I

Name

The name of the corporation shall be: Master Brokers Forum of Broward County, Inc.

ARTICLE II

Principal Office

The principal place of business and mailing address of this corporation shall be: 1111 Brickell Avenue, Suite #2150, Miami, Florida 33131.

ARTICLE III

Purpose

The purpose for which this corporation is organized is to operate as a licensee of Master Brokers Forum, Inc., a Florida corporation, and to honor and recognize the most successful and talented real estate brokers in Broward County, Florida.

ARTICLE IV

Manner of Election

There shall be a minimum of twelve (12) directors and a maximum of eighteen (18). The first Board of Directors shall be appointed by Master Brokers Forum, Inc., a Florida corporation. There shall be three (3) classes of Directors, Class A, Class B and Class C. The Class A Directors shall initially have a one-year term and at the end of one year, the Class A Directors shall be elected to a three-year term. The Class B Directors shall initially have a two-year term and at the end of the two years, the Class B Directors shall be elected to a three-year term. The Class C Directors shall initially have a three-year term and at the end of the three years, the Class C Directors shall be elected to a three-year term. Thereafter, the Executive Board of Directors (Chairman, Vice Chairman, Treasurer, Membership Chairman and Honorary Chairman - past chairmen) shall constitute a Committee which shall elect the Board of Directors whose names will be announced at the Annual Membership Meeting.

ARTICLE V

License Agreement
