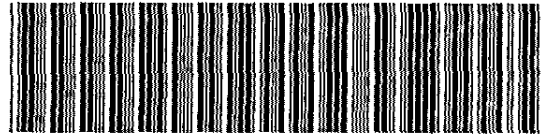



ARTICLE I NAME

The name of the corporation shall be:

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is: The corporation is organized and will be operated exclusively for charitable, scientific and educational purposes within the meaning of section 501(c) (3) of the Internal Revenue Code.
