The following amendment to the Articles of Association was adopted by all of

Article VII is hereby deleted in its entirety and the following provision is

inserted in lieu thereof:

ARTICLE VII

VOTING RIGHTS

The Association shall have one class of voting membership consisting of all Unit Owners (as defined in the Declaration) of Condominium Parcels, who shall be entitled to

one vote for each Condominium Parcel owned. When more than one person holds an
