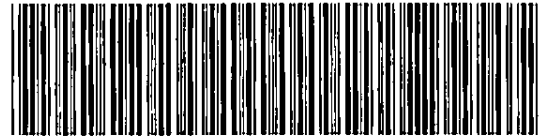

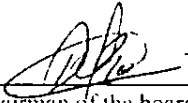

In an extraordinary session, the Board of Directors for the Iglesia Bautista Jesús Es El Señor, Inc. composed of the following members: Brother Kevin Matal, Vice President; Brother Pedro Claudio, Secretary and Brother Eric Carpio, Treasurer. The members got together for the election of Dany Valdes for the position of Pastor and new President of the Corporation which is composed of the church whose name and address are listed at the beginning of the document.

Due to the death of Pastor Fidel Díaz, Pastor and President of the Corporation, the Church sees the need to appoint a new pastor to occupy ministerial, administrative, regulatory and disciplinary functions which support with the position as Pastor and President of the Corporation of our Church.
