

**ARTICLES OF INCORPORATION
OF**

ISLAMORADA COMMUNITY ENTERTAINMENT, INC.

The undersigned, in compliance with Chapter 617, F.S., hereby adopts the following Articles of Incorporation.

Article I – Name: The name of the corporation shall be Islamorada Community Entertainment, Inc.

Article II – Principal Office: The principal place of business is 88765 Overseas Highway, Plantation Key, Florida 33070, and mailing address of the corporation shall be P.O. Box 366, Islamorada, Florida 33036:

Article III – Purpose: The purpose of the corporation are exclusively charitable, educational and civic, and will be accomplished by: developing facilities, leasing and operating facilities, and sponsoring and coordinating cultural and entertainment events for the enjoyment and participation of the community; by attracting additional creative people to the community; by working with government and private interests to support and enhance Islamorada Community Entertainment, Inc.; by soliciting programs and support available from the Florida Keys Council of the Arts, Florida Council of the Arts, the National Endowment for the Arts, and other funding agencies; by the receipt of gifts, grants, and bequests; by generating programs in collaboration with other cultural groups and educational institutions; by promoting Islamorada as a natural focus for creative, cultural and entertainment activities; and through any other such related activities as are desirable and proper within the limitations of Section 501C (3) of the Internal Revenue Code.

Article IV – Manner of Election: The manner in which the Board of Directors are elected or appointed shall be regulated by the Bylaws for this corporation.
