We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation for non-profit under chapter 617, of the Florida's Laws, providing for the creation, liability, rights, privileges, and immunities of a corporation not-for-profit.

ARTICLE I - NAME

The name of this corporation is **OMEGA BAPTIST CHURCH OF IMMOKALEE, INC.**

The mailing address for this not-for-profit corporation is P. O. Box 1037, Immokalee, Florida 34143.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing with the Secretary of State of Florida unless dissolved according to law.

ARTICLE III - PURPOSE

The general purpose of this corporation is to maintain and support worship services of the Almighty God in accordance with its belief, doctrine, faith, or all activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV - QUALIFICATION OF MEMBERS

Members of this corporation shall be composed of any person who desires to be a member and is willing to abide by the principles, rules, beliefs, and regulations of the Church.

ARTICLE V - VOTING RIGHTS

Each member is entitled to one vote at any business meetings.

ARTICLE VI - BOARD OF DIRECTORS

Amendments can be made at any regular or special meeting of the Board of Directors by a majority vote of those directors present and voting, providing notice, and such amendment stating the proposed change shall have been given to the directors at least thirty (30) in advance to such meeting.
