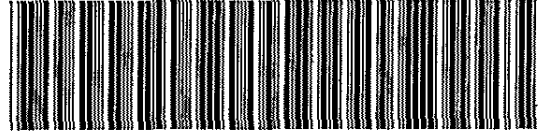

Pursuant to Chapter 617.0202, Florida Statutes the undersigned Florida nonprofit corporation hereby adopts the following Articles of Incorporation:

Article 1

Name

The name of this corporation shall be Crosspoint Christian Church of Cape Coral, Inc.

Article 2

Principal Office

The principal mailing address of this corporation shall be P.O. Box 152526, Cape Coral, FL 33915. The principal place of business shall be Cape Coral, Florida.

Article 3

Purpose

The purpose for which the corporation is organized is:

- 1) To maintain an organization for the practice and enjoyment of Christian worship, services and duties and for sharing the gospel message with our community.
- 2) To do any and all things necessary and appropriate in connection with the foregoing purpose and incidental thereto.
