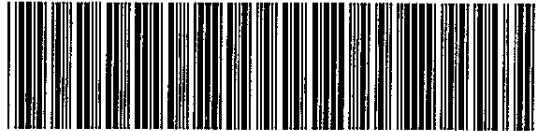

- ONE:** The name and address of this principal corporation is Rejoice Ministries, Inc., 8508 Village Green Road, Orlando, Florida 32818. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.
- TWO:** This Corporation is non-profit religious benefit corporation and is organized to extend deliverance and restoration. The corporation is organized under the Non-profit Public Benefit Corporation Law for Religious, Charitable and Education purposes to establish structured support service for Evangelistic, Consultative, and Other Ministries to support the outreach ministries for the body of Jesus Christ in accordance with the Doctrine of the corporation creed/by-laws as a pastor to spread the gospel of Jesus Christ. The religious program will consist of but, shall no be limited to: Fellowship and Empowerment of women, Homelessness, Health Care, Disadvantage Women and Children, Counseling, and other programs to aid those in need.
- THREE:** Any person may serve as officer of this corporation. Officers shall be elected by the Board of Directors, at any time, and each officer shall hold office until he or she resigns or is removed or is otherwise disqualified to serve, or until his or her successor shall be elected and qualified, whichever occurs first.
- FOUR:** The duration of this corporation shall be perpetual, no stock and shall have no members.

- (a) This corporation is organized and operated exclusively for Religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

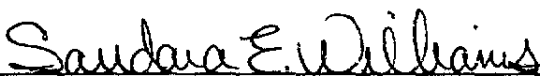
