ARTICLES OF AMENDMENT:

CRUCIAL, INC. (A Florida Not for Profit Corporation)

Crucial, Inc. filed its original Articles of Incorporation on July 25, 2005. The "document number" assigned to this organization by the Florida Department of State at the time of incorporation was N05000007606.

A resolution proposing these Articles of Amendment was adopted by the board of directors of said organization at a special meeting on December 15, 2005 with a quorum being present. This board meeting and vote met the requirements of both the Articles of Incorporation and the bylaws. Article IX of the Bylaws permits the Board to amend the Articles of Incorporation. The corporation has no membership.

The Resolution add the following paragraph as Article XI to its original articles:

ARTICLE XI - DISSOLUTION

The Corporation may be dissolved with the assent given in writing and signed by not less that seventy-five percent (75%) of the directors. Upon winding up and dissolution of the Corporation, the assets of the Corporation remaining after payment of all debts and liabilities shall be distributed to an organization recognized as exempt under section 501(c)(3) of the Internal Revenue Code of 1986 to be used exclusively for charitable and educational purposes. If the Corporation holds any assets in trust, such assets shall be disposed of in such a manner as may be directed by decree of the Circuit Court of the district in which the Corporation's principal office is located, upon petition thereof by the Attorney General or by any person concerned in the liquidation.
