

ARTICLES OF INCORPORATION
OF
GRACE & GLORY WORSHIP CENTER, INC.

In compliance with the requirements of Ch. 617, Florida Statutes (2004), the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a not for profit corporation.

Article I

The name of the Corporation ("Corporation") is **GRACE & GLORY WORSHIP CENTER, INC.**
