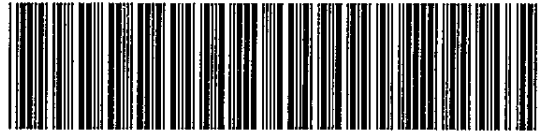

ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of Covenant Partners International Fellowship, Inc. under the Florida Not-For-Profit Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is: **Covenant Partners International Fellowship, Inc.**

ARTICLE II. ADDRESS

The street address of the initial principal office of the corporation is: 5620 Collins Road Unit 807, Jacksonville, Florida 32244. The mailing address of the corporation is: 5620 Collins Road Unit 807, Jacksonville, Florida 32244.

ARTICLE III. DURATION AND COMMENCEMENT

The corporation will exist perpetually, commencing on the date of filing of these Articles of Incorporation.

ARTICLE IV. PURPOSE

To provide a structured place where the abused, hurting, and neglected can come and find healing through prayer, counseling, bible study, workshops and worship. The corporation is organized as a corporation not for profit, exclusively for charitable, educational purposes, including for such purposes, the making of distributions to organizations under section 501(c)(3) of the Federal Internal Revenue Code 1954 (or the corresponding provision of any future United States revenue laws). The activities of the Corporation shall be considered in a manner such that no part of the net earnings of the Corporation shall inure to the benefit of, be distributed to its members, directors, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay a reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article of Incorporation.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these Articles of Incorporation, the Corporation shall not carry on any other activities not permitted to be carried on: by a corporation exempt from Federal income taxes under section 501(c)(3) of the Internal

ARTICLE V. INITIAL REGISTERED OFFICE AND AGENT
