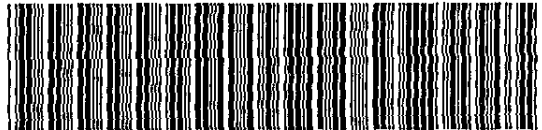



Article 3 Purpose: The reference to Miami-Dade is replaced with Broward County.


Article 4 Definitions: The reference to Miami-Dade is replaced with Broward County.
