AMENDMENT TO ARTICLES OF INCORPORATED 24

The following Amendment to the Articles of Incorporation of River Club of Port Charlotte Homeowners' Association, Inc., a Florida not-for-profit corporation (referred to herein as the "Association") was adopted by the unanimous written consent of the Board of Directors of the Association and by the Declarant as of the \(\frac{1}{2}\) day of November. 2008: There are no members.

1. The following Eighteenth Article shall be added to the Articles of Incorporation:

The Association shall exist in perpetuity; however, in the event that the Association is dissolved, the control or right of access to the property containing the surface water management system facilities shall be conveyed or dedicated to an appropriate governmental agency and, if not accepted, then the surface water management system facilities shall be conveyed to a non-profit corporation similar to the Association.

2. In all other respects, the Articles of Incorporation of the Association shall remain in full force and effect.
