Amendment to the Articles of Incorporation for Tumberry Village North Tower Condominium Association, Inc. (the "Articles")

All other Sections of the Articles shall remain unchanged. In the event of any conflict or inconsistency between the below amendment and the corresponding provisions of the Articles, the terms and provisions of the below amendment shall govern and control.

Subsection 10.1 of the Articles is hereby amended to read as follows:

10.1 Number and Qualifications.

The property, business and affairs of the Association shall be managed by a board consisting of the number of directors determined in the manner provided by the By-Laws, but which shall consist of not less than three (3) directors, nor more than nine (9) directors. Directors need not-be members of the Association. Directors must be natural persons who are 18 years of age or older, must satisfy the eligibility conditions and qualifications to be a Director as set forth in the By-Laws, and are subject to any other procedures related to Director eligibility as set forth in the By-Laws.

Note: New words inserted in the text are underlined, and words deleted are lined through.

Note: The terms herein shall have the same meaning ascribed to them in the Articles, unless the context demands otherwise.
