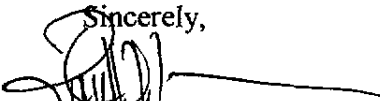

(In Compliance with Chapter 617, F.S., Not for Profit)

ARTICLE I NAME

The name of the corporation shall be **A Voice in the Wilderness Ministries, Inc.**
