ARTICLES OF INCORPORATION

OF

CALVARY OPEN BIBLE COMMUNITY CHURCH, INC.

The undersigned, acting as incorporators of a corporation under the provisions of Chapter 617 of the laws of the State of Florida adopt the following Articles of Incorporation:

ARTICLE I

NAME: The name of this corporation is:

CALVARY OPEN BIBLE COMMUNITY CHURCH, INC.

ARTICLE II

NATURE OF BUSINESS:

The business of this corporation shall be the propagation and dissemination of the Gospel of Jesus Christ through the preaching, teaching, and living of the Full Gospel Message as outlined in the Articles of Faith, constitution and Bylaws of the Open Bible Standard Churches, Inc., having its principal place of business in Des Moines, Iowa, and shall be based on the Bible as the inspired word of the living God. This corporation shall have the power to purchase, lease and construct churches, schools and other building structures useful in connection with the carrying out of the purposes and objects of the corporation.

ARTICLE III

INITIAL REGISTERED AGENT: The street address of the initial registered office is 17395 SW 8th Street, Pembroke Pines, Fl 33029 and the name of the initial registered agent of this corporation is Karl A. Francis. The registered office address and the corporate office mailing address are one and the same as above.

ARTICLE IV

DIRECTORS: The number of directors of this corporation shall not be less than two (2) nor more than twelve (12). The Directors are elected or appointed as stated in the bylaws of the Corporation.

ARTICLE V

DURATION: The period of its duration shall be perpetual from and after the filing of these articles with the Secretary of the State of Florida.

ARTICE VI

ARTICLE VIII

BYLAWS: Bylaws of this corporation shall consist of Article IV of the bylaws of Open Bible Standard Churches, Inc., having its principal place of business in Des Moines, Iowa, and such additional bylaws as may be passed by a majority vote of the members present at any business meeting of this corporation not inconsistent herewith.

MEMBERSHIP: Membership of Calvary Open Bible Community Church, Inc. shall consist of those individuals who are 12 years of age or over and who have been officially and publicly received into membership of the church and who are in accord with the express purpose of Open Bible Standard Churches, Inc. as set forth by the Policies and Principles of Open Bible Standard Churches, Inc. Any child under the age of 12 years shall be considered an integral part of the church in filial relationship. Voting privileges shall be accorded to all members for a period of at least 30 days and who shall have met the qualifications of the active members as set out below.

ACTIVE MEMBERS: Each member must subscribe to and adhere to the doctrine of the full gospel as outlined in the Articles of Faith compiled by the General Board of Directors. Members should be received into Calvary Open Bible Community Church, Inc. once each month, or as often as may be deemed necessary; they shall be examined prior to admission by the pastor and examining committee and shall have shown evidence of genuine born-again experience and a godly Christian life. Members shall be expected to give physical, financial, and spiritual cooperation according to their abilities.

No member of an Open Bible Standard Church shall hold active membership in two Open Bible Standard Churches simultaneously.

The principal pastor of a church and his wife shall be members of his church by virtue of the pastoral call and shall exercise full membership privileges.

Officers -- The officers of Calvary Open Bible Community Church, Inc. shall be as follows: pastor, board of elders of not less than three or more than seven members (including the pastor), two or more deacons (any of whom may be members of the board of elders), and such other officers as may be determined by the policy of the church.

A pastor shall be initially elected to his church for a term of five years and may be re-elected for a term of one to five years, according to the policy of the local church. It is understood that any pastor whose term expires shall be eligible to succeed himself. The officers of the church, except the pastor, shall be nominated by the pastor and the present board of elders, and shall be elected by the majority of the members of the affiliated church present at a membership business meeting duly called for that purpose. All church officers (except pastor) shall be elected or appointed for a term of from one to

ARTICLE IX

AMENDMENTS: Amendments of these Articles of Incorporation may be made at any regular meeting of the membership of the church by a two-thirds vote of the members present and entitled to vote.

ARTICLE X

PERSONAL LIABILITIES: No member of this corporation shall be liable for debts of the corporation. Private property of the members of this corporation shall be exempt from corporate debts and liability.

ARTICLE XI

DISSOLUTION: In the event the church shall cease to support a minister or leader or have regular services for six months, it shall be deemed extinct, and all assets remaining after discharging all obligations and responsibilities of the corporation shall be turned over to Open Bible Standards Churches, Inc. an Iowa corporation, for disposition according to said corporation's policy for extinct churches. If said Calvary Open Bible Community Church, Inc. is then non-existent, such assets shall be turned over to a religious, educational, or charitable organization or organizations whose objectives are in harmony with those of said Open Bible Standard Churches, Inc. Such recipient organization or organizations must also be exempt from Federal Income Taxation under the provision of Section 501 (c) (3), or as such section may be amended. In no event may any of the assets of the corporation upon dissolution thereof, be paid to or inure of the benefit or any

individual member, director, and officer of this corporation, or any other private individual.


