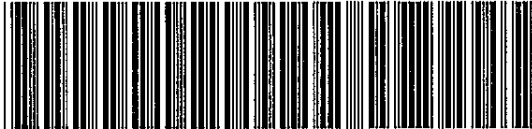

The undersigned incorporator by these articles associate themselves for the purpose of forming a corporation not for profit pursuant to the laws of the State of Florida, and adopt the following articles of incorporation:

**ARTICLE I. NAME**

The name of this corporation is MEDITERRA CONDOMINIUM OWNERS ASSOCIATION, INC. For convenience, the corporation shall be referred to in this instrument as the "Association", these articles of incorporation as the "Articles", and the bylaws of the Association as the "Bylaws".

**ARTICLE II. TERM OF EXISTENCE**

The Association shall have perpetual existence.

**ARTICLE III. PURPOSE**

This Association is organized for the purpose of providing an entity under the Florida Condominium Act (the "Act") for the operation of a condominium located in Escambia County, Florida, and known as Mediterra, A Condominium (the "Condominium"), created pursuant to the Declaration of Condominium (the "Declaration").

**ARTICLE IV. MEMBERS**

The qualification of members and the manner in which the directors shall be elected or appointed shall be contained in the Bylaws.

**ARTICLE V. INITIAL PRINCIPAL AND REGISTERED OFFICE AND  
REGISTERED AGENT**

The address of the registered office of the Company is 417 East Virginia Street, Suite 1, Tallahassee, Florida 32301, and the name of the registered agent at that address is Capital Connection, Inc.

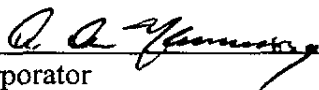
