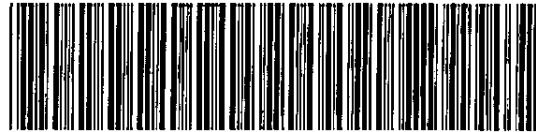

We, the undersigned subscribers, are organizing a not for profit corporation pursuant to the Statutes of the State of Florida providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit.

ARTICLE I

The name of the corporation shall be Threshers Fastpitch, Inc.

ARTICLE II

The principal place of business of said corporation shall be at 101 S. Old Coachman Road, Apt. 611, Clearwater, Florida 33765

ARTICLE III

The specific purpose of this corporation shall be to engage in girls fastpitch softball activities such as practices, tournaments, fundraisers, and any other softball related activities permitted under the laws of the State of Florida or the United States.

ARTICLE IV

The directors of the corporation were elected through a majority vote.

ARTICLE V

The names and addresses of the officers/directors are as follows and shall hold office for the first year of the corporation's existence or until resignation. The number of directors shall be three (3) at all times.

The registered office of said corporation shall be in Pinellas County, Florida, which address shall be 101 S. Old Coachman Road, Apt. 616, Clearwater, Florida 33765, and Kelly Sanchez, is hereby designated as the Registered Agent for service of process for said corporation at said address.

ARTICLE VII

The incorporator of this non profit corporation is Kelly Sanchez, and resides at 101 S. Old Coachman Road, Apt. 616, Clearwater, Florida 33765.

ARTICLE VIII

Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Upon dissolution of this organization, any remaining assets will be distributed to Pinellas County Board of County Commissioners Parks and Recreation Department for the use of public parks and recreation programs.
