## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

Disease Management Network, Inc., a Florida corporation organized and existing under and by virtue of the provisions of the Florida Not for Profit Corporation Act (the "Act"), incorporated on November 17, 2005, hereby amends Article II, <u>Purpose</u>, of its Articles of Incorporation as provided by the terms of Section 617.1006 of the Act as follows:

## ARTICLE II.

## **PURPOSE**

The specific purpose of the business or businesses to be transacted by this Corporation, together with and in addition to the authority and powers conferred by the laws of the State of Florida is to offer charitable, educational and scientific programs providing disease management and health management services and in furtherance thereof to support AlphaNet, Inc. an organization described in Sections 501(c)(3) and 509(a)(2) of the Internal Revenue Code.
