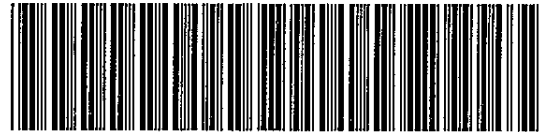

**ARTICLES OF INCORPORATION OF
COMITE DE AYUDA A LA DISIDENCIA-BRIGADA 2506, INC.**

The undersigned incorporator for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

**Article I
NAME**

The name of the Not for Profit Corporation being formed shall be that of **COMITE DE AYUDA A LA DISIDENCIA-BRIGADA 2506, INC.**

**Article II
PRINCIPAL OFFICE**

**Article III
PURPOSES**

The specific purposes for which this Not for Profit Corporation is organized is to provide, as follows:

1. Foster, help, encourage and promote the dissidence in the island of Cuba, by providing assistance to individuals, groups and organizations challenging the present government in the island.
2. The gathering of reading materials be it in books, newspapers, magazines and documents for delivery to the Dissidents in Cuba in which it is preached, taught and advanced the basic and inalienable human rights such as the freedom of speech, the right to unrestricted travel, and to feel secure without the fear of persecution or reprisal for legal and protected activities.
3. The dissemination on a worldwide basis of the news received from the Cuban Dissidents of the continual human rights abuses constituting the official policy of the Cuban State.
