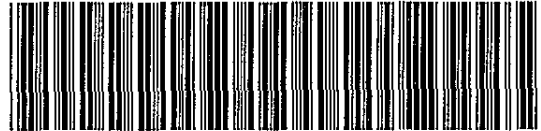

Articles of Incorporation  
of  
The Teen Sanctuary Incorporated

Ocala, Florida

Whereas, it is deemed to be desirable and in the best interests of this Corporation and its directors that it be incorporated in accordance to the State Non-Profit Corporation Act: now therefore, be it:

Resolved, that the undersigned acting as incorporators of a State Corporation under the State Non-Profit Corporation Act, adopt the following Articles of Incorporation for such corporation.

**Article I**  
**Name and Location**

The name of this corporation shall be **The Teen Sanctuary** Incorporated of Ocala, Florida. The temporary address of the said corporation shall be: 7850 NW Gainesville Road Ocala, Florida 34475. The mailing address of this corporation shall be the same address as above.

**Article II**  
**Duration**

The corporation shall have perpetual existence and will commence on January 1, 2006.

**Article III**  
**Purpose**

The mission of the corporation will be for the purpose of caring for and the providing of food and shelter for troubled teens in the community of Ocala and surrounding areas. With the focus of teaching Christian morals and ethics as set forth by the Holy Bible, restoration of relationships with family, help in career decisions and life goals. Help and counseling with teen pregnancy and drug, alcohol, physical, sexual abuses. This corporation is organized as a Non-Profit charitable corporation within the meaning of Section 501(C) (3) of the Internal Revenue Code, including, but not limited to, for such purposes, the establishing and maintaining of buildings and property which are established for the benefit of the troubled teens of the community of Ocala and surrounding areas, providing opportunities for spiritual, physical, intellectual, social, and cultural development.

**Article IV**  
**Initial Board of Directors**

The names and addresses of the initial Board of Directors of the corporation who will serve as directors until the dissolving of said corporation are as follows:

Directors shall be elected as the need arises by a two-thirds vote of the directors.

**Article V**  
**Initial Registered Office and Agent**

The street address of the initial principle registered office of the corporation is 7850 NW Gainesville Rd. Ocala, Fla. 34475. The mailing address of the initial principle registered office of the corporation is as stated above. The name of the initial registered agent of the corporation at that address is President Douglas E. Whittle  
Douglas E. Whittle registered agent / incorporator.

**Article VI**  
**Incorporators**

The names and residence addresses of the subscribers of these Articles of Incorporation are the same as those in Article IV above.

**Article VII**  
**Tax-Exemption Provisions**

No part of the net earnings of the corporation shall be to the benefit of or be distributed to its members, staff, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for the services rendered and to make payments and distributions in the furtherance of the purposes set forth in the corporation's constitution.

No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation. The corporation shall not participate in, nor campaign on behalf of any candidate for public office.

**Article VIII**  
**Conduct of Corporate Affairs**

The conduct of the affairs of the corporation will be limited as outlined in the Constitution and Bylaws of the corporation. The powers of the corporation are to be regulated as outlined in the Constitution and Bylaws of the corporation. The manner in which directors are elected or appointed will be as provided in the Bylaws of the corporation.

**Article IX**  
**Dissolution of Corporate Affairs**

If this corporation should ever be dissolved, all of its assets after payment of all outstanding debts and obligations, costs, and expenses of such dissolution shall be distributed to the initial directors of the corporation.

**Article X**  
**Amendments to Articles of Corporation**

The Articles of Incorporation may be amended by a two-thirds vote of those members present and voting when the members of the corporation are meeting in conference as provided in the Bylaws of the corporation.

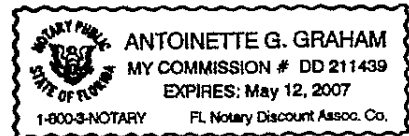

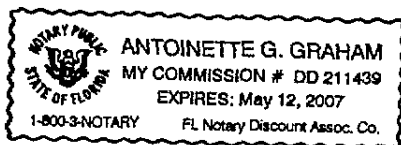
