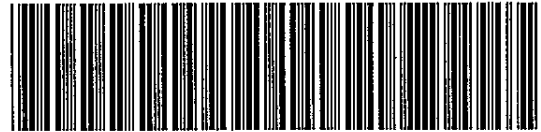

**ARTICLES OF INCORPORATION
OF
TEMPLE OF LIGHT FELLOWSHIP MINISTRIES, INC.**

(A Florida Corporation not for Profit)

The undersigned, acting as Incorporator of a corporation, adopts the following Articles of Incorporation for such corporation.

ARTICLE 1

NAME AND PRIVILEGES

Section 1. The name of the Corporation shall be Temple of Light Fellowship Ministries, Inc. and its present location, Jacksonville, Duval County, Florida.

Section 2. The Corporation shall have a seal which shall be inscribed as Temple Of Light Fellowship Ministries, Inc.

Section 3. On all Church matters that come before the church for action each member present is entitled to vote.

Section 4. One third percent of the roll of the membership shall constitute a quorum, except that for the election of officers, two third percent.

ARTICLE 11

MINISTRY LOCATION

Section 1. The place where the business of Corporation shall be transacted is 6802 Commonwealth Avenue, Jacksonville, Florida 32254, or other places as the Board of Trustees may from time to time properly designate. The Church mailing address: 8959 Spring Harvest Lane West, Jacksonville, Florida 32244.

Section 2. The period of duration of this Corporation is perpetual, unless dissolved according to law and/or Bylaws.

ARTICLE 111

PURPOSE OF ORGANIZATION

Temple Of Light Fellowship Ministries, Inc. is a Christ-centered Church designed to minister the Gospel of Jesus Christ and to minister Biblical

principles for practical living. The specific purpose of this Corporation is:

(a) Religious

- i. To preach, teach, motivate, and disseminate the Word of God to men and women in a local Church by the direction of the Lord Jesus Christ and under the leadership of the Holy Spirit in accordance with all of the Commandments and provisions as set forth in the Holy Bible, the irrevocable Word of God.
- ii. An ecclesiastical form of government shall be established.
- iii. To establish a Faith Creed, Code of Doctrine, and a discipline form of worship.
- iv. Provide Ordination of ministers, deacons, etc. upon completion of the prescribed course of study, designated by the Corporation's Church Ministries.
- v. Establishment of a church membership based upon acceptance of a recognized creed and belief, professing Jesus Christ as their Savior, and acknowledge the Holy Ghost, the Holy Church, the Communion of Saints, the forgiveness of sin, the resurrection of Christ and life everlasting, and giving in support of the Church.
- vi. Spread the Word of the Gospel through seminars, radio, television, establishment of Church literature, and other forms of mass media for the purpose of educating the individual in the Word of God.
- vii. Establishing any type of school for the preparation of ministers who minister to the church. To license, ordain and qualify its members for ministerial duties.
- viii. To perform all rites, ritual ceremonies of the gospel ministries, including sacred matrimony. That all acts, missions, administrations and ministries are entitled to full credit and faith, whenever and wherever providence may afford.
- ix. Subject to the laws of the various States governing the marriage ceremony, with all of the rights and privileges to conduct Counseling Classes for men and women in Premarital Counseling before marriage, as ordained by the Word of God; develop and implement spiritual manifestation, insight and righteousness classes.
- x. To organize Churches, Prayer Conferences, Men and Women Ministries, Children Ministries, Teen Abstinence Program, School of Independent

- xi. Growth; School of Evangelism, School of Learning and Development for Preschoolers, etc.
- xii. Conduct a local and international ministry in various communities, cities, states and other countries abroad.
- xiii. The corporation shall exist perpetually unless otherwise sooner dissolved by the Board of Directors or according to law. All Directors shall be in good and regular standing, according to the Bylaws.
- (b) Serve as an outreach ministry for the Whole Family and the community.
- (c) Promote and encourage cooperation with other organizations, ministering within the community.
- (d) To acquire and hold such property, either real or personal, for Church purposes, as may be necessary for its membership and the worship of God.

As a means of accomplishing the above purposes and methods, the Corporation shall have the following powers:

- (a) To accept, acquire, receive, take and hold by bequest, devise, grant, gift, purchase, exchange, lease, transfer, judicial order or decree, or otherwise, for any of its objects and purposes, any property, both real and person, of whatever kind, nature of description and wherever situated.
- (b) To sell, exchange, convey, mortgage, lease transfer or otherwise dispose of, any such property, both real and personal, as the objects and purposes of the Corporation may require, subject to such limitations as may be prescribed by law.
- (c) To borrow money, and, from time-to-time, to make, accept, endorse, execute and issue bonds, debentures, promissory notes, moneys borrowed or in payment for property acquired, or for any of the other purposes of the Corporation, and to secure the payment of any such obligations by mortgage, pledge, deed, indenture, agreement or other instrument of trust, or by other lien upon assignment of, or agreement in regard to all or any part of the property, rights, or privileges of the Corporation wherever situated, whether now owned or hereafter to be acquired.
- (d) To invest and reinvest its funds in such stock, common or preferred, bonds, debentures, mortgages, or in such other securities and property, real and personal, as it shall deem advisable, subject to the limitations and conditions contained in any bequest, devise, grant, or gift, provided such limitations and conditions are not in conflict with the provisions of 501(c)(3) of the Internal revenue Code of 1986 an applicable regulations thereunder, as they now exist or as they may be amended.

ARTICLE 1V

OUR BELIEF IN GOD

Section 1. We believe in God, the Father Almighty, the author and Creator of all things. We believe that Jesus Christ is the Son of God, the Second person in the Godhead of the Trinity of Triune Godhead. We believe the Holy Ghost or Holy Spirit is the Third person of the trinity, proceeds from the Father and the Son, is of the same substance, equal in power and glory, and is together with the Father and the Son to be believed, obeyed and worshipped. We believe that the Baptism of the Holy Ghost is an experience subsequent to conversion and sanctification, and that tongue-speaking is the consequence of the baptism of the Holy Ghost with manifestation of the fruit of the spirit.

ARTICLE V

ORGANIZATION AND MEETINGS FOR WORSHIP AND WORK

Section 1. The Church provides for meetings and organizations as follows:

- A. For worship service, the entire body is asked to join in on each Lord's Day [Sunday] morning and evening, and each Tuesday and Wednesday evening, and any other designated service times.
- B. Discipleship School is to be conducted each Lord's Day for all people; to be under the direction of the Pastor and Superintendent, who shall be a regular officer/and member of the Church.
- C. Church Training shall be conducted on each second Saturday of each month, and supervised by the Pastor, Ministerial Staff, or an Evangelist.
- D. The Men of the Church shall be organized as the Men of Valor for the purpose of having men's Bible Study, prayer groups and various spiritual growth initiative programs, meeting every Friday evening.
- E. The Women of the Church shall be called Women of Excellence and S.A.R.A.H. representing noble women who are [Strengthening, Assisting, Restoring, Affiliating and Helping] will meet every first and third Monday evening.

Section 2. The Lord's Supper shall be duly celebrated on the first Lord's Day of each month unless otherwise ordered by vote of the Church, or designated by the Pastor.

Section 3. The Monday evening following the last Lord's Day in each month shall be the regular time for business meetings of the Church.

Section 4. Special call meetings shall be held for any specified purpose on a Monday evening if ordered by the Board of Directors or Pastor.

Section 5. The annual meeting of the Church shall be held each year at the principal office of the Corporation in Jacksonville, Florida or at any other place in the State of

Florida, at 10:00 o'clock in the forenoon on the first Monday in January of each year, if not a legal holiday, and if a legal holiday, then at the same time on the next succeeding Monday not a holiday for the purpose of election meeting.

Section 6. All questions shall be settled by a majority of those present and voting, except as otherwise provided in the Bylaws.

Section 7. All questions of procedures not provided for the Bylaws shall be determined according to Robert's Rule of Order.

ARTICLE VI

OFFICERS AND COMMITTEES

Section 1. Members, officers, program leaders and committees

MEMBERSHIP REQUIREMENTS

Individuals are eligible for membership under Temple Of Light Fellowship Ministries upon agreements to the following guidelines:

1. Have a belief in God, The Father Almighty
2. Believe in the Baptism of the Holy Ghost, and that tongue-speaking is an experience subsequent to conversion and sanctification
3. Participate in the financial support of the ministry, missions, conferences in accordance to Malachi 3:10
4. Be in obedience to the pastor and established church governments
5. Participate in prayer, fasting and be personally involved in its various missions and ministries
6. Particulate in witnessing crusades in the community, compelling the lost and unsaved to come that they might be saved.
7. Shall not misrepresent this church in any ungodly manner
8. Maintain a positive attitude and work well with others, regardless of race, religion or religious affiliation
9. Membership of this church in nontransferable
10. Adhere to the Statement of Faith of this church
11. Participate in Ministry of helps, assisting in the growth of the church
12. Share information that enhance growth in individual members
13. Present any grievances in a godly manner to the Pastor

Any member may be removed from this church for the following causes:

- a. Failure to comply with the Word of God
- b. Members creating a physical disturbance with other members or non members
- c. Misrepresentation of any business transaction of church business affairs
- d. File a claim for damages against the Pastor or any member of the Board of Directors
- e. At any time, members may withdraw from the church with a written statement

to the pastor. All properties in their possessions must be returned to the church immediately.

Any member can be reinstated in a lawful assembly with final approval of the Board of Directors and Pastor.

MODERATOR

The Pastor shall be the moderator. In the absence of the Pastor, the Co-Pastor shall preside; in the absence of both of these, the Prophetess, and Chairman of Deacons shall serve as moderator. In the absence of these four, the Chairman of Evangelism shall serve as moderator. In the absence of these five the Clerk of the Church shall call the Church to order and a moderator pro tem shall be elected.

TRUSTEES

The trustees are the legal representatives, assigned also as custodians of the Church property. The Church thus looks to them for upkeep and repairs of the building and equipment and other forms of protection, rules and regulations regarding the use of Church properties. Trustees should work in close cooperation with the Board. They too, should never forget that they are a committee of the Church, subject to the Church's directions and with no authority except as it is granted them. This committee will be subdivided into a committee on observance of the Lord's Supper. Under careful instructions of the Pastor this committee shall well in advance see that all is in readiness for the Lord's Supper.

CLERK

The clerk of the Church shall keep in a suitable book a record of all the actions of the Church. The clerk shall keep a register of the names, social security numbers, with dates of joiners, dismissal, or deaths, together with a record of baptism. The clerk shall also notify all officers, members of committees of dismissal voting official reports, and give legal notice of all meetings where such notice is necessary. The clerk shall work closely with the Pastor, recording and filing Church materials. Whenever invitations are received [accepted or rejected] shall notify those persons at least two weeks or 24 hours, whichever come first. The Church clerk shall consider it a part of his/her responsibility to promote loyalty and competency in this church.

ASSISTANT CLERK

The Assistant Church Clerk must attend all regular and special meetings of the Church. The Assistant Clerk maybe asked to serve as Secretary of special committees or boards whose minutes should become part of the church records. The Assistant Clerk will make an accurate record of the proceedings of these Church meetings and later inscribe the permanent record in a book that the Church will provide.

TREASURER

There shall be one treasurer to be known as treasurer. He or she shall meet with the financial chairman, or deacons, and shall have his/her books always open for inspection.

Said treasurer shall make a monthly detailed statement to the financial chairman, or deacons, and the Church; all receipts and disbursements and others pertaining to the financial status of the Church. Said treasurer shall be bonded in such amount as the Church shall designate. Said treasurer shall keep separate accounts of various funds as designated by the Church. Said treasurer shall make all bank deposits for the Ministry.

FINANCIAL SECRETARY

The chief tasks of the secretary are to keep a record of the Church offerings: tithes, general offerings, mission, housing allowances, etc., maintaining a weekly record of those offerings. On Sunday's after the financial and assistant secretary has removed the money from the envelopes and verified the amount on the envelopes, they must initial the envelopes, document financial sheet, then give all money to the Treasurer for deposit. The financial secretary has an important responsibility. All money from members is kept confidential. Any other persons than the Pastor, or an appointee will not discuss this business.

SUPERINTENDENT OF DISCIPLESHIP SCHOOL

The Pastor will serve as superintendent, unless otherwise stated, then that appointee shall have the oversight of the entire school and shall administer it with the aid of the Council consisting of Co-Pastor, Prophetess, Associate Pastor, Youth Director, Director of Children's Ministry, general officers and departmental directors. The term of office shall be one year.

WARRIOR'S FOR THE KING DIRECTOR

The director will oversee this ministry, designed for children (ages 3 - 11) in a method of teaching which captures the attention of this age group for growth and understanding of the Word on their level of understanding. The term of office shall be one year.

MEN OF VALOR DIRECTOR

He shall have the oversight of the entire Men Of Valor Ministry, and shall administer with the aid of the Pastor. The term of this office shall be one year. The *purpose* of this ministry is to help men find and fulfill their potential as men who want to leave a legacy with young men and boys who are learning the dynamics of manhood.

WOMEN OF EXCELLENCE DIRECTOR

She shall have the oversight of the entire Women Of Excellence, and Women of S.A.R.A.H. Ministry and shall administer it with the aid of the Pastor or Prophetess. She shall be in office for one year.

WOMEN PERSONAL BIBLE STUDY DIRECTOR

She has the responsibility to empowered women with information for marital and single relationships. Understanding the dynamics of godly principles and godly living. The meeting time is once a month, on a Monday evening at 7:00p.m. unless otherwise designated by the Pastor..

Bible Study: In Bible Study you are to look for, a command to obey, a promise to claim, a sin to forsake, a prayer to echo something about God, a best verse, and something to apply to your life. [Tuesday] evenings at 7:00p.m.

Seed Harvest Prophetic Ministry: A ministry that will impart wisdom through the prophetic word in Scriptures, and teaching members how to sow seeds to receive a harvest from their giving unto the Lord. [Friday] evenings at 7:00p.m.

CHILDREN MINISTRY DIRECTOR

The director will encourage children to become seriously involved with Children Ministry. They will participate in all of the activities offered: Sing-Along Choir, Dance Ministry, Counseling sessions, Sharing and Praying time that may enhance their spiritual lives. They must promote and attend special events and training for children. Form prayer groups among those who are interested. The term of this office is for one year.

After School Enrichment Program: [Volunteers are needed to implement this vision] Training children on each Tuesday from 3:30p.m. to 6:30p.m. in personal communicating skills; homework assistance, office procedures; check writing, reconciling check book, budgeting; Bible Dramatization, play therapy,, music and dance therapy, etc.

Child Day Care Facility: [Volunteers are needed before this project is begun] For the purpose of educating children ranging from the age of two to five years of age; teaching sight and listening oriented skills, word pronunciation, bible quotations, music, language, math, science, play therapy, growth and development in communication skills.

Lighthouse Outreach Program: Teaching males and females the art of praying, interceding for five people for five minutes a day, seven days a week. Each person will be able to drive through a designated community and choose five houses at random to pray for.

Prison Ministry: Start a holistic prison ministry that will equip and empower inmates, former offenders and their families to be productive in their respective community, and be a role model for local churches and prison ministries for the 21st century; to hold non-denominational church services, having Scriptural readings, personal testimonies, singing and praying with inmates and/or other fellowship churches. Assist men and women after being incarcerated in Independent Life Skills, which include job application, resume writing, office procedures, telephone communication skills, restoration of family, etc.

Card Care Ministry: A ministry designed by Pastor Herb to witness through cards, letters, and personal contact to members and their love ones of this ministry, demonstrating the love of God. A community outreach program for those who are despondent, oppressed by circumstances, encouraging them in their future walk.

Intercessory Prayer Ministry: This ministry was birthed from Pastor Herb and Prophetess

Betty to call people to intercede for men in this city and local community, to rise upon their circumstance and be the headship of the family, building strong families, and building strong marriages, and building strong churches.

Music Ministry: (*Volunteers are needed to implement the vision*) The music ministry is composed of the orchestra, choirs (adult, youth and children), and praise teams who minister at all worship services including social services and fellowships.

Personal Ministries/Altar Workers: The purpose of this personal ministry/altar worker is to minister to those who respond to the appeals Pastor makes at the end of each lesson. The Altar Workers assist Pastor Herb and Prophetess Betty in the ministry to those persons who come forward for prayer.

Singles Fellowship: This ministry consists of those members who are single for some unknown reason: widowed, divorce, never married or separated. This group will meet with Pastor Herb and Pastor Betty every first Tuesday.

Special Care Committee: This ministry is designed to make sure every member is properly cared for during times of bereavement, illness and/or birth of a child.

Temple Of Light Bookstore: To have Christian appropriate books for all teaching ages. To provide efficient customer service to those who desire to purchase books, videos and cassette tapes of our services. We are very pleased in the fact that the Gospel is being taken beyond these walls and that our services is our purpose.

Teen Abstinence Program: Teaching teens the significance of being abstinence form sexual activities until marriage. Educating them on the importance of dating. Professional volunteers are to teach Sex Before Marriage: Pros and Cons; Soul-Mates; Life Skills: Learning About and Knowing My Body.

Biblical Resources for Debt Management: Educating adults on the importance of being good stewards over their money-not being wasteful but realistic in their spending. Teaching communicating with creditors; budgeting reconciliation; eliminating debt within a timely manner.

CHURCH COMMITTEES

THEIR TERMS SHALL BE

Section 2. The Pastor shall remain the same. The term of all other officers shall be elected yearly at the annual meeting as provided by the by-laws and they shall be elected by a majority vote of members.

ELECTIONS

Section 3. All elections and appointments will be held at the annual meeting in

November, except: The committee on Committees shall be appointed by the Pastor at the business meeting in December. This committee shall consist of at least five members who shall be appointed by the Pastor.

1. The duty of this committee shall nominate at the January business meeting, all Church committee members. Nominations may be heard from the floor. All Church committee members shall be members of Temple Of Light Fellowship Ministries.
2. Each Church committee shall have a designated number of members elected for one-year term.
3. The Committee of Committees recommends the Chairman of each committee. The Chairman is elected for one year. At the first committee meeting the committee shall elect a Vice-Chairman, a Secretary and a Treasurer.
4. Vacancies that occur during the year shall be filled by recommendation to the Church by the Committee of Committees.
5. The Committee of Committees shall bring any and all recommendations to the Pastor.

ARTICLE VII

CHURCH MEMBERSHIP

Section 1. MEMBERSHIP OF THIS CORPORATION

Persons will be received into the membership of Temple Of Light Fellowship Ministries by:

1. Public professions of faith in the Lord Jesus Christ as a personal Savior and following baptism into the full fellowship,
2. Public profession of needing Christ as a personal Savior, and receiving the baptism of the Holy Ghost, following baptism into the full fellowship, or
3. Public profession of needing to be under watch care until a personal relationship with he Lord Jesus Christ as a personal Savior and following baptism into the full fellowship.
4. The statement that one has trusted Christ as a personal Savior and was baptized into a full gospel Church as the record of membership and baptism should be made available.
5. The membership of the Church shall be two [2] classes of persons: members of the congregation [nonvoting, except the Board of Directors [voting].
6. All persons joining the Church who are not saved, filled with the baptism of the Holy Ghost and water baptism will receive the Lord Jesus Christ as their Savior through the baptism of the Holy Ghost, then baptizing with water in the name of the Father, and of the Son, and of the Holy Ghost.

Section 2. BAPTISMS

Those who are candidates for baptism, will be an important part of the church, and a deep concern of the membership. Their names will be announced before the congregation for

baptism. A special prayer, by calling their names individually will be called. Before baptism, they must be truly saved and understand the significance of their decision and action. Baptisms shall be administered by the pastor, or by some other person designated by the Pastor or authorized by the Church.

Section 3. OFFERINGS

Opportunity shall be given in suitable ways for the members and congregation to give tithes, and offerings; seed offerings to the Budget of the Church. The offerings should be given cheerfully; for the Lord loves a cheerful giver; tithes are given for us t receive from God. If we trust God we will trust Him in our finances and give according to His word and the devour won't take from the members. The offerings are things presented to God in worship. The offerings should be made to God alone-tithe offering, gift offering, etc.

Scripture Belief:

Luke 6:38 "Give, and it will be given to you. A good measure, pressed down, shaken together and running over, will be poured into your lap. For with the measure you use, it will be measured to you."

Gen. 14:18-20 "Then Melchizedek King of Salem brought out bread and wine. He was priest of God Most High, and he blessed Abram, saying, "Blessed be Abram by God Most High, Creator of heaven and earth. And blessed be God Most High, who delivered your enemies into your hand." Then Abram gave him a tenth of everything. In Heb. 7:2 "...and Abraham gave him a tenth of everything."

ARTICLE VIII

BOARD OF DIRECTORS

Section 1. General Powers. The business of this organization shall be managed by a Board of Directors consisting of four [4] members, together with the officers of this organization. Any officer of this corporation shall maintain faithfulness and godly character with integrity in their responsibilities essential to the function of tat office. At least one of the directors elected shall be a resident of the State of Florida and a citizen of the United States. The directors to be chosen for the ensuing year shall be chosen at the annual meeting of this organization in the same manner and style as the officers of this organization and they shall serve for a term of one [1] year. The Board of Directors shall have the control and management of the affairs and business of this organization. Such Board of Directors shall only act in the name of the organization when it shall be regularly convened by its chairman after due notice to all the directors of such meeting. Two-third of its members of the Board of Directors shall constitute a quorum and the meetings of the Board of Directors shall be held regularly on the second Monday of January of each year. Each director shall have one vote and such voting may not be done by proxy. The Board of Directors may make such rules and regulations covering its

meetings as it may in its discretion determine necessary. Vacancies in the Board of Directors shall be filled by a vote of the majority of the remaining members of the Board of Directors for the balance of the year. The President of the organization by virtue of his office shall be Chairman of the Board of Directors. The Board of Directors shall select from one of their members a secretary. A director may be removed when sufficient cause exists for such removal. The Board of Directors may entertain charges against any director. A director may be represented by counsel upon any removal hearing. The Board of Directors shall adopt such rules for this hearing, as it may in its discretion consider necessary for the best interests of the organization.

ARTICLE 1X

OFFICERS

Section 1. Powers of Officers.

[a] The initial officers of the organization shall be as follows: Pastor/President: Vice President: Secretary: Treasurer: The **President** shall preside at all membership meetings. He shall by virtue of his office be Chairman of the Board of Directors. He shall present at each annual meeting of the organization an annual report of the work of the organization. He shall appoint all committees, temporary or permanent. He shall see all books, reports and certificates required by law are properly kept or filed. He shall be one of the officers who may sign the checks or drafts of the organization. He shall have such powers as may be reasonably construed as belonging to the chief executive of any organization.

No person shall be invited to speak, teach or minister in the Church without his approval. He shall be designated attorney-in-fact for the Church by virtue of his office. He shall have the authority to appoint and approve any assistants that would be necessary to property carry out the work of the Lord.

/b/ The Associate Pastor-Vice President: An associate pastor-vice president shall in the event of the absence or inability of the Pastor/President to exercise his office shall become acting pastor/president of the organization with all the rights, privileges and powers as if he had been the duly elected president.

[c] **The Secretary:** The Secretary shall attend all sessions of the board held at the office of the Church and act as clerk thereof and keep the minutes and records of the organization in appropriate books. It shall be his/her duty to file any certificate required by any statute, federal or state. He/she shall give and serve all notices to members of this organization. He/she shall be the official custodian of the records and seal of this organization. He/she may be one of the officers required to sign the checks and drafts of the organization. He/she shall present to the membership at any meetings any

communication addressed to him/her as Secretary of the organization. He/she shall submit to the Board of Directors any communications, which shall be addressed to him/her as Secretary of the organization. He/she shall attend to all correspondence of the organization and shall exercise all duties incident to the office of Secretary.

[d] **The Treasurer:** The Treasurer shall keep full and accurate account of the receipts and disbursements in books belonging to the Corporation, and shall deposit all moneys and other valuable effects in the name and to the credit of the Corporation in such banks and depositories as may be designated by the Board of Directors, but shall not be personally liable for the safekeeping of any funds or securities so deposited pursuant to the order of the Board. He shall disburse the funds of the Corporation as may be ordered by the Board and shall render to the President and Directors at the regular meeting of the Board, and whenever they may be required, accounts of all his transactions as Treasurer and of the financial condition of the Corporation. He shall perform the duties usually incident to the office of the Treasurer and such other duties as may be prescribed by the Board of Directors or by the President.

Section 5. Resignation, Removal:

[a] **Resignation.** In the event the Pastor should voluntarily choose to leave, he shall designate his successor. Said designated successor shall be chosen with the advice and consent of the Board of trustees, and the Board of directors.

[b] **Removal.** In the event the pastor shall have serious charges preferred against him or his ministry has ceased to be effective, the matter shall be brought to the Board of Directors. Any officer elected or appointed by the Board of Directors may be removed by the Board of Directors whenever in its judgment the best interests of the Corporation would be served thereby, but such removal shall be without prejudice to the contract rights, if any, of the officer so removed.

Section 6. Vacancies. A vacancy in any office because of death, resignation, removal, disqualification, or otherwise, may be filled by the Board of Directors for the unexpired portion of the term.

Section 7. Special Meetings. Special meetings of the Board of Directors may be called by or at the request of any two (2) Directors, and shall be held at the principal office of the Corporation.

ARTICLE X
INITIAL DIRECTORS

The manner in which the Directors of the Corporation shall be elected or appointed shall be governed by the provisions of the Bylaws of the Corporation. The names and street addresses of the initial directors of the Corporation are:



ARTICLE XII

DISSOLUTION

Section 1. Dissolution

Upon the dissolution of the Church, the Board of Trustees shall, after the payment of all the liabilities of the Church, dispose of all of the assets of the Church exclusively for the

purposes of the Church in such manner, or to such organization or organizations organized and operated exclusively for the purposes of the Church in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, or religious purposes.

ARTICLE XIII

SEAL

The Board of trustees shall provide a corporate seal, which will be circular in form and shall have inscribed thereon the name of the Corporation, the State and year of incorporation and the words 'Corporate Seal.'

ARTICLE XIV

CONTRACTS, CHECKS, DEPOSITS AND FUNDS

Section 1. Contracts. The Board of Directors may authorize any officer or officers, agents or agents of the Corporation, in addition to the officers so authorized by these Bylaws, to enter into any contract or execute and deliver any instrument in the name of and on behalf of the Corporation, and such authority may be general or may be confined to specific instances.

Section 2. Checks, Drafts or Orders. All checks, drafts or orders for the payment of money, notes or other evidences of indebtedness issued in the name of the Corporation shall

be signed by such officer or officers, agent or agents of the Corporation, and in such manner as shall from time to time be determined by resolution of the Board of Directors. In the absence of such determination by the Board of Directors, such instruments may be signed by either the Treasurer or the President of the Corporation.

Section 3. Deposits. All funds of the Corporation shall be deposited from time to time to the credit of the Corporation in such banks, trust companies, or other depositories as the Board of Directors may select.

Section 4. Gifts. The Board of Directors may accept on behalf of the Corporation any contribution, gift, bequest or devise for any purpose of the Corporation.

ARTICLE XV

FISCAL YEAR

The fiscal year of the Church shall be the calendar year.

ARTICLE XVI

AMENDMENT OF BYLAWS

The Articles of Incorporation and these Bylaws may be altered, amended, or repealed and new bylaws may be adopted by a two-thirds (2/3)-majority vote of the Board of Directors of the Church at any regular or special combined meeting of the Board of Directors. At least fourteen (14) days written advance notice of a meeting called for the purpose of altering, amending or repealing the Church's Bylaws or Articles of Incorporation shall be given to each member of the Board of Directors.
