Amendments to these Articles shall be proposed and adopted in the following manner:

- 1. Proposal. Amendments to these Articles may be proposed upon a vote of the majority of the entire Board adopting a resolution setting forth the proposed amendment to these Articles, directing that it be submitted to a vote at a meeting of members or amendments may be proposed by a written petition signed by one-third (1/3) of the members of the Association upon a vote of seventy five percent (75%) of the voting interests entitled to vote at a meeting for which notice of the proposed amendment has been given.
- 3. Vote Necessary. In order for such amendment or amendments to become effective, the same must be approved by at least a majority of the participating members, present and voting, in person or by proxy, at a meeting at which a quorum is established or by written agreement provided a quorum participates. , at a duly called meeting, by an affirmative vote of seventy five percent (75%) of the votes of the entire voting interests entitled to vote thereon.
