The attached amendments shall be effective on the date of filing of these Articles of Amendment by the Florida Department of State.



#### AMENDMENT TO THE ARTICLES OF INCORPORATION OF DEER RUN HOMEOWNERS' ASSOCIATION #14, INC.

WHEREAS, the membership of DEER RUN HOMEOWNERS' ASSOCIATION #14, INC. ("Association") has determined that it is in the best interest of the Association to amend the Articles of Incorporation of the corporation in the fashion stated below, to correct the Board of Director membership which was in the best interest of the original developer, but no longer applies since homeowners are now in charge of the Association; and

WHEREAS, the Articles of Incorporation allow the same to be amended by a two-thirds (2/3rds) vote of the members present at a duly called Association membership meeting; and

WHEREAS, the Association membership voted on the following amendment at a duly called meeting of the Association.

NOW THEREFORE, BE IT RESOLVED by the DEER RUN HOMEOWNERS' #14, INC., as follows:

1. Article VII, first paragraph, of the Articles of Incorporation of the Deer Run Homeowners' Association #14, Inc., is hereby amended by changing the first sentence to read "The affairs of the Association shall be managed by a Board of not less than three (3) nor more than seven (7) Directors all of whom need be members of the Association."
