

AMENDMENT TO THE ARTICLES OF INCORPORATION OF WOODLAND ESTATES PROPERTY OWNERS' ASSOCIATION, INC.

The original Declaration of Covenants and Restrictions is recorded in Official Records Book 4397 at Page 1243 of the Public Records of Palm Beach County, Florida.

As used herein, words <u>underlined</u> are added and words hyphened through are deleted.

Article IX(B)(1) of the Articles of Incorporation, as amended, shall be amended to read as follows:

Amendments to the Articles of Incorporation shall be proposed and adopted in the following manner:

- B. A resolution approving a proposed amendment may be proposed by either the Board of Directors or by the members of the Association. Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, providing such approval is delivered to the Secretary at or prior to the meeting. Except as elsewhere provided:
- 1. Such approvals must be by not less than eighty percent (80%) fifty-one (51%) percent of the votes of the membership of the Association owners who are in attendance at a meeting, either in person or by proxy, providing a quorum has been obtained.
