We, the undersigned, each being a natural person competent to contract, do hereby associate ourselves for the purpose of acting as incorporators of a corporation not for profit under the laws of the State of Florida, pursuant to the provisions of chapter 617 of the Florida Statutes with the powers, rights, privileges, and immunities as hereinafter set forth.

Article I

PURPOSE

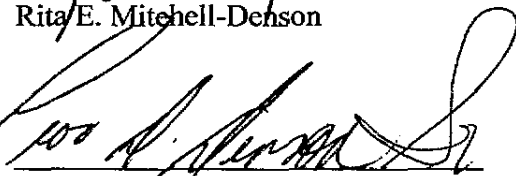
Amendments to the Articles of Incorporation may be proposed by any member of the Board and shall be adopted by the majority vote of a quorum of Directors.

DISSOLUTION

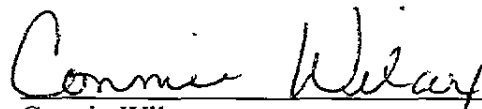

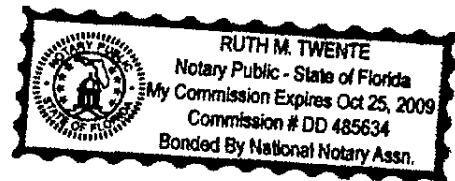
