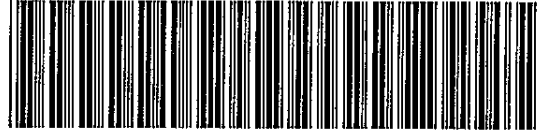

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I
Name
