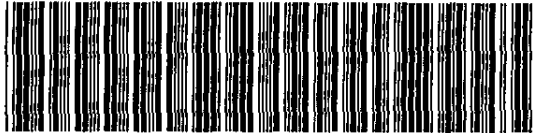

The undersigned incorporators by these articles associate themselves for the purpose of forming a corporation not for profit pursuant to the laws of the State of Florida, and adopt the following articles of incorporation:

ARTICLE I. NAME AND ADDRESS

The name of this corporation is MIDPOINT PROFESSIONAL CENTER CONDOMINIUM ASSOCIATION, INC. For convenience, the corporation shall be referred to in this instrument as the "association," these articles of incorporation as the "articles" and the bylaws of the association as the "bylaws." The street address of the association is 4790 Barkley Circle, Building A, Fort Myers, Florida 33907.

ARTICLE II. TERM OF EXISTENCE

The association shall have perpetual existence.

ARTICLE III. PURPOSE

This association is organized for the purpose of providing an entity under the Florida Condominium Act (the Act) for the operation of a condominium located in Lee County, Florida, and known as Midpoint Professional Center, a Condominium (the Condominium), created pursuant to the declaration of condominium (the Declaration).

ARTICLE IV. MEMBERS AND DIRECTORS

The qualification of members and the manner of their admission shall be as regulated by the bylaws. The method of electing or appointing directors is set forth in the bylaws.

ARTICLE V. INITIAL REGISTERED OFFICE  
AND REGISTERED AGENT
