The undersigned, acting as the incorporator of a Florida not for profit corporation under the Florida Not For Profit Corporation Act, Chapter 617 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

**ARTICLE I  
NAME**

The name of the Corporation is "Florida Federation of Republican Women, Inc."

**ARTICLE II  
PRINCIPAL OFFICE AND MAILING ADDRESS**




