ARTICLES OF INCORPORATION
In compliance with Chapter 617.F.S., (not for profit)

ARTICLE I NAME

The name of the corporation shall be: Mid Florida Cruisers, Inc.

ARTICLE II PRINCIPAL OFFICES

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:
