**I. Name**

**The name of the Corporation shall be: Focusing On Communities, Inc.**

**II. Principal Office**

**The principal place of business shall be 2030 Southwest Road, Sanford, Florida 32771**

**III. Purpose**

**The Corporation is formed exclusively for charitable, educational and scientific Purposes. To this end, the corporation shall be operated exclusively for charitable purposes within the meaning of Section 501c3 of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions or organizations that qualify as exempt organizations under Sections 501c3 of the Internal Revenue Code 1986, as now enacted or hereafter amended. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes. No part of assets, income or profit of the Corporation shall be distributable to, or inure to the benefit of, its directors, officers or members except to the extent permitted under the Florida Nonprofit Corporation Code. The Corporation shall not take any steps which will serve to facilitate the transaction of specify business by its directors, officers or members to promote the private interest of any director, officer or member or engage in any activities which would constitute a regular business of a kind ordinarily carried on for profit.**

#### **IV. Manner of Election**

The governing body of the corporation shall consist of a Board of Directors made of not less than three(3) nor more than seven (7) members. The Board of Directors shall have all the powers and authority of directors as provided in the Florida Nonprofit Corporation Code. Any member of the Board may be re-elected to the Board without limitation. Upon any vacancy occurring on the Board of Directors the, remaining Directors shall have the right to fill the vacancy for the balance of the unexpired term, which shall continue until the next annual meeting of the Board of Directors. The Board of Directors shall be elected in accordance with the by-laws
