ARTICLE I NAME

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

Said corporation is organized exclusively for charitable purposes, including the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. All donations made to Rocking to Rebuild, Inc. (outside of promotion and production costs) will be used to support the rebuilding efforts of residents along the Gulf Coast that have suffered hurricane damages. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

Officers are elected as specified in the bylaws, by a majority vote of active membership.

Directors will be elected in the same manner as officers, by 65% of membership majority vote.

ARTICLE V INITIAL DIRECTORS AND/OR OFFICERS
