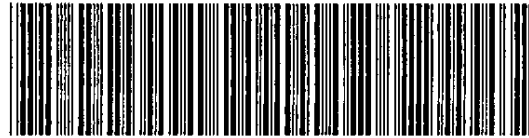



ARTICLES OF AMENDMENT

CORRECTION OF ARTICLE – 1 SECTION 1.02 – PURPOSE

THIS CONGREGATION IS ORGANIZED AS A CHURCH EXCLUSIVELY FOR CHARITABLE AND RELIGIOUS PURPOSES WITHIN THE MEANING OF CODE SECTION 501(C) (3) OF THE INTERNAL REVENUE CODE OF 1986 (OR CORRESPONDING PROVISION OF ANY FUTURE UNITED STATES REVENUE LAW), INCLUDING THE ESTABLISHING AND MAINTAINING OF RELIGIOUS WORSHIP IN THE PROCLAMATION OF THE GOSPEL OF THE LORD JESUS CHRIST.

CORRECTION OF ARTICLE – SECTION 4.03

(A) THE CHURCH SHALL ESTABLISH THE CRITERIA OF ELIGIBILITY TO SERVE AN OFFICER OF DEACON, TRUSTEE, LEADERSHIP POSITIONS OF MISSIONS, OR CHURCH STAFF. ANYONE DESIROUS OF HOLDING ONE OF THESE OFFICES MUST ADHERE TO THE FOLLOWING STIPULATIONS

1) ALL APPLICATES AFFIRM THEIR AGREEMENT WITH THE STATEMENT OF FAITH AS SET FORTH IN ARTICLE 2.

2) ALL APPLICATES MUST ATTEND ANNUALLY ONE OR MORE INTERNAL LEADERSHIP WORKSHOPS AND REVIVALS.

3) ALL APPLICATES MUST ATTEND ONE OR WEEKLY TEACHINGS BIBLE STUDY, BTU-BIBLE TRAINING, UNIT/BAPTIST TRAINING, SUNDAY SCHOOL AND LEADERSHIP TRAINING.

(B) ALL APPLICATES MUST BE APPROVED DURING THEIR INITIAL APPLICATION BY THE PASTOR, DEACON BOARD, AND THE BOARD OF TRUSTEES. SUBSEQUENTLY, ALL APPLICATES WILL BE REVIEWED ANNUALLY TO QUALIFY FOR OFFICE AND APPROVED BY THE CHURCH.

(C) THE PASTOR, DEACON BOARD, AND BOARD OF TRUSTEES HAVE THE AUTHORITY TO REPLACE ANY APPLICATE NAMED TO LEAD A MISSION IF THAT LEADER IS NOT FUNCTIONAL WITHIN THE BAPTIST POLICY WITH APPROVAL BY THE CHURCH.

(D) THE PASTOR, CURRENT DEACON BOARD, AND CURRENT BOARD OF TRUSTEES HAVE THE RIGHT TO APPOINT THE CHAIRMAN OF THE DEACON BOARD, CHAIRMAN OF FINANCE BOARD AND CHAIRMAN OF THE TRUSTEE

BOARD. FINAL APPROVAL IS REQUIRED BY THE CHURCH MEMBERS IN ACCORDANCE WITH THE BY LAWS.

CORRECTION OF ARTICLE – SECTION 4.04 – TERM OF OFFICE

- (A) 1) THE RELATIONSHIP BETWEEN THE PASTOR AND THE CHURCH SHALL BE PERMANENT UNLESS DULY DISSOLVED AT THE OPTION OF EITHER, THE PASTOR OR THE CHURCH BY GIVING ONE MONTHS NOTICE, OR BY MUTUAL CONSENT.
- 2) THE CALLING OF A PASTOR OR SEVERANCE OF THE RELATIONSHIP BETWEEN THE PASTOR AND CHURCH MAY BE CONSIDERED AT ANY REGULARLY SCHEDULED CHURCH CONFERENCE MEETING. PROVIDED NOTICE TO THAT EFFECT IS GIVEN FROM THE PULPIT TO THE CHURCH TWO (2) SUNDAYS PRIOR TO THE REGULARLY SCHEDULED CHURCH CONFERENCE MEETING.
- 3) A QUORUM IS DEFINED BY THE MAJORITY OF VOTING MEMBERS PRESENT AT A DULY CALLED MEETING OF THE CHURCH. A MAJORITY OF VOTING MEMBERS PRESENT AT A DULY CALLED CHURCH CONFERENCE MEETING HAVE THE AUTHORITY TO CALL A PASTOR, OR TO SEVER THE RELATIONSHIP BETWEEN THE PASTOR AND THE CHURCH. A TERMINATED PASTOR SHALL RECEIVE A MINIMUM SEVERANCE PAY OF THREE (3) MONTHS NORMAL COMPENSATION. (REFER TO 3.01, 3.02 AND 3.06 FOR MEMBERSHIP REQUIREMENTS).
- (B) ALL OFFICERS AND CHURCH POSITIONS IN THE CHURCH SHALL BE ONE YEAR, WITH THE EXCEPTION OF THE PASTOR. OFFICERS AND CHURCH LEADERSHIP RUN FOR RE-ELECTED OR RE-APPOINTED AT THE EXPIRATION OF THEIR TERM.
- (C) WITH THE EXCEPTION OF THE PASTOR, VACANCY OCCURRING IN ANY POSITION OR MINISTRY MAY BE FILLED AT ANY REGULAR CHURCH CONFERENCE MEETING. THE PASTOR, DEACON BOARD, AND BOARD OF TRUSTEES APPOINT A PERSON TO THE POSITION FOR THE REMAINDER OF THE EXISTING TERM WITH THE APPROVAL OF THE CHURCH.
- (D) ALL ELECTED AND APPOINTED OFFICERS SHALL SERVE IN THEIR RESPECTIVE OFFICE UNTIL THE SUCCESSORS ARE DULY ELECTED AND APPOINTED.

(E) MEMBERS OF THE DEACONS MINISTRY MAY BE REMOVED FROM OFFICE FOR CONDUCT CONSIDERED UNBIBLICAL, AS DETERMINED BY THE MEMBERS OF THE CHURCH. THEY ARE REMOVED UPON MAJORITY VOTE OF THE REMAINING MEMBERS OF THE DEACONS MINISTRY AND RETIFIED BY THE CHURCH MEMBERS.
