ARTICLES OF INCORPORATION

OF

**INTERNATIONAL BROTHERHOOD OF BOILERMAKERS LOCAL 199
HOLDING CORPORATION**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation shall be International Brotherhood of Boilermakers Local 199 Holding Corporation ("Company").

**ARTICLE II
PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be 8374 Devoe Street, Jacksonville, Florida 32220.

**ARTICLE III
PURPOSES**

The purposes of the Company are to represent the interests of the International Brotherhood of Boilermakers Local 199 (the "Union") and to hold any real estate or other property as necessary or convenient on behalf of the Union; to encourage and promote the professional growth of the members of the Union; and to engage in any activity or business related to the operation of this Company and to have all powers permitted and granted under the law of the State of Florida with respect to non-profit corporations.

**ARTICLE IV
BOARD OF DIRECTORS**

The corporation shall have three (3) initial Directors. The number of Directors may be increased or decreased from time to time in the manner prescribed by the Bylaws, but shall never be less than one.
