ARTICLES OF INCORPORATION

OF

I the undersigned incorporate, hereby make, acknowledge and file these Articles of Incorporation for the purpose of forming a non-profit corporation under the laws of the State of Florida, pursuant to Florida Statutes 617.

ARTICLE I
NAME

The name of this corporation shall be:

ARTICLE II
NATURE OF BUSINESS

The general purpose for which this Corporation is organized is to transact any or all lawful business for which non-profit corporations may be incorporated under Chapter 617 Florida Statutes. The specific purpose of this non-profit corporation shall be to be the "Association"

ARTICLE III
MEMBERSHIP

The association shall have six members, one for each building. All persons who are owners of individual buildings within said office park shall automatically be members of this corporation. Such membership shall automatically terminate when such a person is no longer the owner of a parcel. Membership in this corporation shall be limited to such parcel owners. Subject to the foregoing, admission to and termination of membership shall be governed by the Declaration of Restrictive Covenants and individual Condominium Declarations that shall be filed among the public records of Broward County, Florida.

ARTICLE IV
TERMS OF EXISTENCE

The term of this corporation shall commence with the filing of these Articles of Incorporation. The Corporation shall exist perpetually unless dissolved according to law.

ARTICLE VI
BOARD OF DIRECTORS

The powers of the Corporation shall be exercised by or under the authority of, and the business and affairs of the Corporation shall be managed under the direction of, a Board of Directors, which shall have three (3) directors initially. The number of directors may be increased or decreased by the shareholders from time to time as provided in the By-Laws of the Corporation but shall never be less than three. The Directors subsequent to the first Board of Directors, shall be elected at the annual meeting of the membership for a term of one (1) year, or until their successors shall be elected and shall qualify. Provisions for such election, and provisions respecting the removal, disqualification and resignation of Directors and for filling vacancies on the Directorate, shall be established by the By-laws.

ARTICLE IX
DIVIDENDS

There shall be no dividends paid to any of the members nor shall any of the income of the corporation be distributed to its Board of Directors or Officers. In the event there are any excess receipts over disbursements as a result of performing services, such excess shall be either refunded to the Building Owners or kept by the Association and applied against the Association's expenses for the following year as shall be determined by a vote of the Unit Owners, subject to approval by the Board of Directors of the Association. The Corporation may pay compensation in a reasonable amount to its officers, directors or employee members in conformity with its purposes and Florida Statutes, and upon dissolution or final liquidation, may take distribution to its members as is permitted by the Court having jurisdiction thereof, and no such payment, benefit or distribution shall be deemed to be dividend or distribution of income.




