

The undersigned, acting as incorporator of a corporation under Chapter 617 of Florida Statutes, adopts the following Articles of Incorporation:

#### **ARTICLE I**

#### NAME OF CORPORATION

The name of the corporation is MINISTERIO INTERNACIONAL REINO DE DIOS, INC.

#### **ARTICLE II**

# **DURATION THE OF CORPORATION**

The term of duration of this corporation shall be perpetual. The date and time of the commencement of corporate existence shall be effective upon the filing of the Articles of Incorporation.

# 501(c) (3) LIMITATIONS

#### 1. CORPORATE PURPOSES AND EXCLUSIVITY:

This corporation is organized exclusively for tax exempt, charitable, religious, and educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

The corporation will promote, conduct and establish Christian ministry of every type and kind, including churches, education, media, publications, conferences, concerts, itinerant ministry, mentoring, discipleship, training, ministerial certification, licensing, and ordination etc.

The corporation will have the vision of evangelize, affirm, disciple and send disciples to the mission field within the local church, other cities or nations.

The corporation shall employ staff as required to accomplish the goals and objectives of the corporation.

The corporation will adopt and use a corporate seal.

The corporation will promote and conduct public education through available means.

The corporation will receive funds for the furtherance of its nonprofit, tax exempt purposes.

The corporation will enter into, make, perform and carry out contracts of every kind for any lawful purpose without limit to the amount and with any person, corporation; to draw, make, accept, endorse, discount, issue and execute promissory notes, warrants, and other negotiable or transferable interests.

The corporation will act as a Trustee under any trust incidental to the principal objects of the corporation and to receive, hold, administer and expend funds and property subject to such trust.

The corporation will take, purchase or otherwise acquire; to own, hold, occupy, use and enjoy; manage, exchange, let, demise or

otherwise dispose of real state, buildings and improvements an every right, interest and state therein without limit thereof and wherever the same be situated; to erect, construct, alter, and repair buildings; to assume any and ever kind of contract, agreement with any person, firm, corporation or association or any Federal, State, or other government for the erection, construction, alteration, repair, renewal, equipment, improvement, development, use enjoyment, leasing, management or control of any buildings, improvements or structures of any kind wherever the corporation may be situated.

The corporation will borrow and loan money and to give and receive evidence of indebtedness and security thereof.

The corporation will use all media for the furtherance of its nonprofit, tax exempt purposes.

#### 2. NO PRIVATE INUREMENT:

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its officers, or other private persons, except that the corporation shall be authorized to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above.

# 3. LOBBYING AND POLITICAL CAMPAIGNS:

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in any political campaign on behalf of or in opposition to any candidate for public office.

#### 4. DISSOLUTION:

Upon dissolution the assets of the corporation, after the payment of all the liabilities of the corporation shall be distributed to a tax exempt organization under code section 501(c)(3) and its regulations, selected by the board of trustees.

If this process does not result in the disposition of all the assets of the corporation, then the court of applicable jurisdiction of the county in which the principal office of the corporation is then located, shall determine, which such organizations shall receive the balance of the assets of the corporation.

# INMUNITY AND INDEMNIFICATION

The private property of the Trustees agents or employees shall be non-assessable and shall not be subject to the payment of any corporate debts, nor shall the Trustees and members of the corporation become individually or corporate liable or responsible for any debts or liabilities of the corporation.


