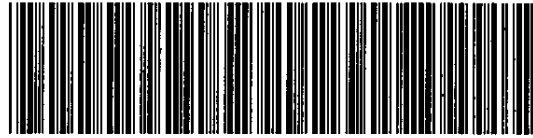

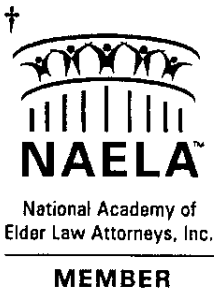



ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF

STAR CENTER FOUNDATION, INC.

STAR CENTER FOUNDATION, INC., a Florida corporation, pursuant to the provisions of section 607.1006, Florida Statutes, and under its corporate seal and the hands of its President and Secretary, MAXIMO H. SALINAS and DEBRA J. JACOBY adopts the following amendments to its Articles of Incorporation:

The Board of Directors of said Corporation at a meeting called and held on July 11<sup>th</sup>, 2007, with all officers and directors of the Corporation, adopted the following Resolution:

BE IT RESOLVED that the Board of Directors, with agreement by the officers, deem it advisable and hereby declares it to be advisable that an Articles X and XI be added to the Articles of Incorporation which shall read as follows:

**ARTICLE X-CHARITABLE PURPOSE OF CORPORATION**

This Corporation is organized exclusively for charitable and educational purposes, including for such purposes the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code.

**ARTICLE XI-USE OF CORPORATE EARNINGS**

No part of the net earnings of the Corporation shall inure to the benefit of, of be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the Corporation shall carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

THERE ARE NO MEMBERS OF THE CORPORATION OR MEMBERS ENTITLED TO VOTE  
IN WITNESS WHEREOF, said Corporation has caused this Certificate to be signed in its name by its  
President and Secretary and its corporate seal to be hereunto affixed this 11<sup>th</sup> day of  
July, 2007.
