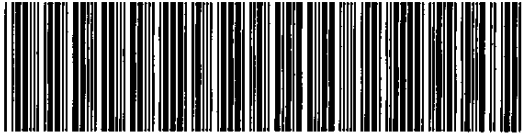

**ARTICLES OF INCORPORATION
OF
CITRUS COUNTY CHILDREN'S ADVOCACY CENTER, INC.

**ARTICLE I
NAME**

The name of this Corporation is CITRUS COUNTY CHILDREN'S ADVOCACY CENTER, INC., a Nonprofit Florida Corporation.

**ARTICLE II
TERM OF EXISTENCE**

The existence of this Corporation shall begin on the date and time these Articles are filed with and accepted by the Florida Department of State, in accordance with section 617.0203, Florida Statutes. This Corporation shall exist perpetually.

**ARTICLE III
INCORPORATOR**

The name and business address of the Incorporator of this Corporation are as follows:

The rights and interests of the Incorporator shall automatically terminate when these Articles are filed with the Department of State.

**ARTICLE IV
PURPOSES**

The general purpose for which this Corporation is organized is to operate exclusively for charitable purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The specific and primary purpose for which this Corporation is organized is to establish and maintain a Children's Advocacy Center in Citrus County, Florida, for all children in the county suspected of having been abused or neglected.

ARTICLE V
PUBLICLY SUPPORTED TAX-EXEMPT NONPROFIT CORPORATION

No part of the net earnings of this Corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that this Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof.

No substantial part of the activities of this Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, this Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE VI
DISSOLUTION

Upon the dissolution of this Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE VII
BOARD OF DIRECTORS

The affairs of this Corporation are to be managed by a Board of Directors of no less than three (3), and no more than fifteen (15) members. Additional directors in any odd number may be added to the Board as set forth in the duly adopted By-Laws. New directors shall be elected annually by the members according to the By-Laws that may be in existence from time to time.

The initial officers of this Corporation shall be the President, the Vice President, the Secretary, the Treasurer, and such other officers and assistant officers as may be created from time to time by the Board of Directors. The officers shall be elected annually by the Board of Directors.

ARTICLE VIII
INITIAL PRINCIPAL OFFICE, MAILING ADDRESS AND REGISTERED AGENT

The initial registered agent of this Corporation is Jack A. Moring, and the street and mailing address of the initial registered office is 7655 West Gulf to Lake Highway, Suite 12, Crystal River, Florida 34429.

ARTICLE IX
ADMINISTRATION

This corporation is organized, and shall be operated, on a non-stock basis.

ARTICLE X
MEMBERSHIP

The qualifications for members and the manner of their admission shall be regulated by the By-Laws of this Corporation.

This Corporation shall provide for equal membership and employment opportunities to all persons regardless of race, color, religion, sex, age, disability, or natural origin.

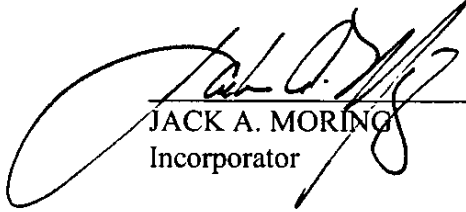
ARTICLE XI
BY-LAWS

The Board of Directors, by majority vote, are authorized to establish By-Laws for the corporation not inconsistent with these Articles of Incorporation, and to amend same from time to time.

ARTICLE XII
AMENDMENTS TO ARTICLES OF INCORPORATION

This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation. Amendments to the Articles of Incorporation shall be proposed by the Board of Directors in the form of a resolution, which must be adopted by a majority vote of all members present and those represented by proxy at any meeting of the membership called for that purpose. Notwithstanding anything herein to the contrary, amendments which are required or advisable to obtain or maintain the Corporation's tax exempt status may nevertheless be adopted at a meeting of the Board of Directors by a unanimous vote of the directors then in office.


