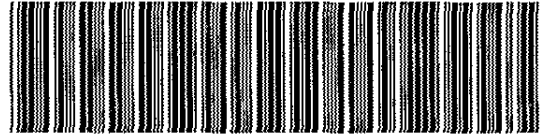

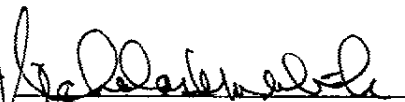

ARTICLE I

We, the undersigned Subscriber and Directors, all natural persons competent to contract, hereby associate ourselves together for the purpose of forming a nonprofit corporation under Chapter 617 the laws of the State of Florida.

ARTICLE II

The name of this Corporation shall be **MESSAGE MINISTRIES & MISSIONS, INC.**

ARTICLE III

This Corporation shall exist perpetually.

ARTICLE IV

This Corporation is organized for the purpose of operating a non-profit ministry with a primary objective to proclaim the Gospel of Jesus Christ anywhere in the world. The organization is non-denominational, ministering whenever and wherever invited to proclaim the Gospel.

ARTICLE V

The qualifications for members will be stated and regulated by the Bylaws of this Corporation.

ARTICLE VI
