THIS CAUSE having come before the Court on October 17, 2006, for uncontested Final Hearing of Dissolution of Marriage upon the Petitioner/Wife's Petition for Dissolution of Marriage, and the Court having reviewed the pleadings and the court file, having heard testimony of the Petitioner/Wife, MARICEL D. SALLADAY, having examined proof of residency, and being otherwise fully advised in the premises, the Court makes the following findings of fact and conclusions of law:

1. This Court has jurisdiction of the subject matter and the parties hereto.
2. The Petitioner/Wife has been a resident of the State of Florida for more than six (6) consecutive months prior to the filing of her Petition for Dissolution of Marriage.
3. There are no children of this marriage and none are contemplated.
4. The parties freely and voluntarily entered into a Marital Settlement Agreement dated October 6, 2006, after fair and full financial disclosure, amicably settling their various property rights, spousal support, and other obligations to their mutual satisfaction, and




