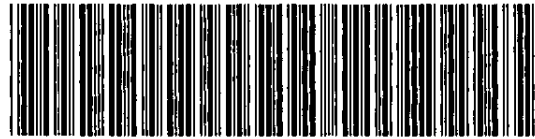

### Section III
