# ARTICLES OF INCORPORATION OF ISLAND CLUB OWNERS ASSOCIATION, INC.6

The undersigned, acting as incorporator of a corporation under the non-profit Corporation Act of the State of Florida, adopts the following articles of incorporation.

## **ARTICLE I - NAME**

The name of the corporation is ISLAND CLUB OWNERS ASSOCIATION, INC.

# ARTICLE II - EXISTENCE AND DURATION

Existence of the Association shall commence with the filing of these Articles of Incorporation with the Secretary of State, State of Florida. The Association shall exist in perpetuity.

# ARTICLE III - PURPOSES AND POWERS

The purposes for which the corporation is organized are:

- A. To operate ISLAND CLUB OWNERS ASSOCIATION and to undertake the performance of, and to carry out the acts and duties incident to the administration of ISLAND CLUB OWNERS ASSOCIATION in accordance with the terms, provisions, conditions, and authorizations contained in these Articles, the Bylaws of ISLAND CLUB OWNERS ASSOCIATION, and the Declaration of Covenants, Conditions and Restrictions of ISLAND CLUB recorded among the public records of Seminole County, Florida;
- B. To carry out the duties and obligations given by the Declaration of Covenants, Conditions and Restrictions of ISLAND CLUB recorded among the public records of Seminole County, Florida; and
- C. To establish By-Laws and Rules and Regulations for the operation of ISLAND CLUB OWNERS ASSOCIATION and to provide for the formal administration of ISLAND CLUB OWNERS ASSOCIATION, and to enforce the Declaration of Covenants, Conditions and Restrictions of ISLAND CLUB recorded among the public records of Seminole County, Florida, and the By-laws of ISLAND CLUB OWNERS ASSOCIATION.
- D. The Association shall operate, maintain and manage the surface water or stormwater management system(s) in a manner consistent

with the St. Johns River Water Management District permit number issued for the development of the Island Club Subdivision, and the requirements contained therein, and applicable District rules, and shall assist in the enforcement of the Declaration of Covenants and Restrictions which relate to the surface water or stormwater management system.

E. The Association shall levy and collect adequate assessments against members of the Association for the costs of maintenance and operation of the surface water or stormwater management system.

# **ARTICLE IV - MEMBERSHIP**

The qualifications for members and the manner of their admission shall be regulated by the Declaration of Covenants, Conditions and Restrictions of ISLAND CLUB recorded among the public records of Seminole County, Florida, and the By-laws of ISLAND CLUB OWNERS ASSOCIATION.

# ARTICLE V - REGISTERED OFFICE

The initial registered office of the corporation shall be at 1053 Maitland Center Commons Blvd., Suite 100, Maitland, FL 32751.

# ARTICLE XII DISSOLUTION

In the event of termination, dissolution or final liquidation of the Association, the responsibility for the operation and maintenance of the surface water or stormwater management system must be transferred to and accepted by an entity which would comply with Section 40C-42.027, F.A.C., and be approved by the St. Johns River Water Management District prior to such termination, dissolution or liquidation.
