

AGREEMENT AND PLAN OF MERGER

THIS AGREEMENT AND PLAN OF MERGER is made this 28 day of June, 2018, and effective for all purposes the 1st day of July, 2018, by and between THE ROSE AND JACK ORLOFF CENTRAL AGENCY FOR JEWISH EDUCATION OF BROWARD COUNTY, INC., a not for profit 501(c)(3) corporation organized and existing under the laws of the State of Florida (hereinafter referred to as the "Merging Company") and THE UNITED JEWISH COMMUNITY OF BROWARD COUNTY, INC., a not for profit 501(c)(3) corporation organized and existing under the laws of the State of Florida (hereinafter referred to as the "Corporation").

WHEREAS, the Board of Directors of the Corporation and the Board Directors of the Merging Company deem it advisable and generally in the best interests of the respective parties that the parties effect a merger (the "Merger") pursuant to the applicable laws, with the Corporation being the surviving entity.

NOW, THEREFORE, in consideration of the premises and of the mutual agreements herein contained, and of the mutual benefits hereby provided, the sufficiency of which is hereby acknowledged, it is agreed by and between the parties hereto as follows:

1. Merger. At the Effective Time (as defined in Section 5 hereof), Merging Company will be merged with and into the Corporation in a statutory merger pursuant to this Agreement and Plan of Merger and in accordance with applicable provisions of Florida law.
2. Effect of Merger. At the Effective time, (a) the separate existence of the Merging Company shall cease and the Merging Company shall be merged with and into the surviving Corporation and the surviving Corporation, a Florida not for profit corporation, will be the surviving entity pursuant to the terms of the Articles of Merger; (b) the Certificate of Incorporation and Bylaws of the surviving Corporation, as in effect immediately prior to the Effective Time, shall be the Certificate of Incorporation and Bylaws of the surviving entity until duly amended in accordance with their terms and applicable law; (c) the Directors of the surviving Corporation shall be the Directors of the surviving Corporation as the surviving entity; and (d) the Merger shall have all of the effects provided by applicable law.
3. Filing. The Corporation shall promptly cause Articles of Merger in form and substance satisfactory to each party hereto and its respective counsel to be executed and filed with the office of the Secretary of State of the State of Florida, and the Corporation and Merging Company shall promptly cause Articles of Merger in form and substance satisfactory to each party hereto and its respective counsel to be executed and filed with the office of the Secretary of State of the State of Florida.
4. Conduct of the Merging Company and the Corporation. Until the Effective Time each of Merging Company and the surviving Corporation shall continue to conduct its business without material change and shall not make any distribution or other disposition of assets, capital or surplus, except in the ordinary course of business or with the consent of the other.
5. Effective Time. The merger shall be effective on the date of filing with the State of Florida (the "Effective Date").

6. Rights and Liabilities of Merging Company. At and after the Effective Time, without further act or deed, all of the rights, privileges and powers, and all of the property, real, personal and mixed of, and all debts due to Merging Company, as well as all of the things and causes of action belonging to Merging Company shall be the property of the surviving Corporation as they were the property of Merging Company, and the title to any real estate vested by deed or otherwise in Merging Company shall not revert or be in any way impaired by reason of the Merger; all rights of creditors and all liens upon any property of any of the parties hereto shall be preserved unimpaired, and all debts, liabilities, and duties of the respective parties hereto shall thenceforth attach to the surviving Corporation and may be enforced against it to the same extent as if such debts, liabilities, and duties had been incurred or contracted by it.

7. Further Assurances. If, at any time after the Effective Time, the surviving Corporation shall consider or be advised that any further deeds, assignments or assurances in law or any other actions are necessary, desirable or proper to vest, perfect or confirm of record or otherwise, in it, the title to any property or rights of Merging Company and the surviving Corporation acquired or to be acquired by reason of, or as a result of, the Merger, Merging Company and the Corporation agree that such entities and their proper officers and directors shall execute and deliver all such proper deeds, assignments and assurances in law and do all things necessary, desirable or proper to vest, perfect or confirm title to such property or rights in the Corporation and otherwise to carry out the purpose of this Agreement and Plan of Merger, and that the proper officers and directors of the Corporation are fully authorized and directed in the name of the Merging Company and the Corporation or otherwise to take any and all such actions.

8. Governing Law. This Agreement and Plan of Merger shall be governed by, and construed in accordance with, the laws of the State of Florida, without regard to any applicable conflicts of law.


9. Termination. This Agreement and Plan of Merger may be executed in counterparts, all of which shall be considered one and the same agreement and shall become effective when one or more counterparts have been signed by each party and delivered to the other party, it being understood that both parties need not sign the same counterpart.
