**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
CRYSTAL LAKE WEST HOMEOWNERS ASSOCIATION, INC.
(A Florida Not For Profit Corporation)**

Pursuant to Section 617.1006, Florida Statutes, **CRYSTAL LAKE WEST HOMEOWNERS ASSOCIATION, INC.**, a Florida not for profit corporation (the "Association"), hereby adopts the following Articles of Amendment:

FIRST: The Articles of Incorporation were filed on October 27, 2006, and assigned document number N06000011244.

SECOND: Article I of said Articles of Incorporation is amended in its entirety to change the name of the Association from "**CRYSTAL LAKE WEST HOMEOWNERS ASSOCIATION, INC.**", by deleting the provision of said Article I as the same now exists and by substituting in lieu thereof, the following:

"ARTICLE I

NAME OF CORPORATION

The name of the corporation is **CRYSTAL LAKES WEST HOMEOWNERS ASSOCIATION, INC.** (the "Association")."

THIRD: All other provisions of the Articles of Incorporation remain unchanged and in full force and effect.

FOURTH: The foregoing amendment was adopted by the Members of the Association on the 25 day of June, 2007, and the number of votes cast for the amendment was sufficient for approval.

IN WITNESS WHEREOF, **CRYSTAL LAKE WEST HOMEOWNERS ASSOCIATION, INC.**, has caused these Articles of Amendment to Articles of Organization to be executed, this 25 day of June, 2007.
