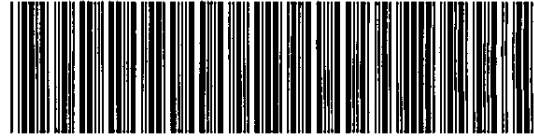

account of Forerunner Christian fellowship


